I would like to thank the Kosciusko Leadership Academy and R. R. Donnelley & Sons Co. for giving me the opportunity to participate in this, the 7th Class of The Kosciusko Leadership Academy. Most of the names were obtained at the State Library in Indianapolis, and a few were obtained at the Warsaw Public Library by searching through microfilm copies of the Northern Indianian.

KOSCIUSKO COUNTY JUSTICES OF THE PEACE

Nearly twenty years would pass from the time that Indiana gained statehood in 1816 until this part of Indiana was organized into Kosciusko County¹. Of course, once the county was created there was an immediate need to fill positions in all levels of County and Township government. One such position was "Justice of the Peace". A Justice of the Peace, commonly referred to as a "JP"² was empowered by our State Constitution of 1816: Article V, Section 12³.

A competent number of Justices of the Peace shall be elected by the qualified electors in each Township, in the several Counties, and shall continue in office five years, if they shall so long behave well, whose powers and duties shall, from time to time, be regulated and defined by law.

JPs have a fairly long history. Their roots go back to 14th century England⁴. And, they were here in 1805 when our State was the Indiana Territory⁵. Although JPs still exist in many States today, Indiana eliminated the position in 1975.

A JP was a lower court judge. These judges normally heard cases involving minor amounts of money or in criminal cases, ones which were less severe⁶. The following cases taken from JP dockets illustrate the various types of cases heard.

William W..... complains of the defendant in words and figures as follows: and says that on or about the 6th day of April 1885 his minor son David W..... did work for said Thomas R.... on his farm, at farm work commencing on the 6th day of April 1885, at the rate of \$18.00 per month, and did work for 2 months, 4 days and 3/4 of one day which amounts to \$39.29, with a credit of \$20.60, leaving a balance of \$18.69. Said William W.... demand judgement of \$18.69 and all other proper relief. Summons issued. Constable delivered summons. On the 6th day of November 1885, the day set for trial the parties appeared and by compromise and agreement the defendant pays \$15.00 and the plaintiff pays costs.

And now on the 14th day of June 1878 the Plaintiff filed his complaint in words and figures to wit

Now comes Abraham H..... and being duly sworn upon his oath says that on or about the 12th day of June AD 1878 at the County of Kosciusko and State of Indiana as affiant verily believes the said William M..... did in a rude angry and insolent manner and with unfawful intent to do personal violence did assault one Abraham H..... with an ax and other missels contrary to the forms of the Statutes in such cases made and provided and against the peace and dignity of the State of Indiana.

And the same day to wit June 14th 1878 I issued a State Warrant for the arrest of the defendant and delivered the same to Elijah Devore Constable of said county June the 15th 1878. Warrant returned endorsed. This writ came to hand June 14 1878 and the same day I have the defendant in court as commanded in the within writ.

And June 15th 1878 by request of William M..... the defendant Subpoena issued for Newton L....., and I delivered the same to Oliver Shinn Deputy Constable of Etna Township and made the same returnable fourthwith and administered to him the oath required by law.

June 15 1878 the parties being present and in consequence of the Court having other pressing business and litigation it was agreed by the parties that this cause be continued until the 27th day of June 1878.

June 27th 1878 case called and no answer and dismissed for want of prosecution the defendant being present.

Plaintiff appeared and made oath in due form to the correctness of this account, which is complaint in this action.

Defendant was duly summoned to appear for trial but did not appear, but made default.

It is therefore adjudged that the plaintiff ought to recover judgement. I therefore without prejudice or partiality render judgement in favor of the plaintiff.

In conclusion, I've tried to preserve a piece of Kosciusko County history in one manageable document. No judgements were presented either for or against the position of Justice of the Peace; for that would be a topic for discussion deserving of a paper on its own merit. The JP's were an integral part of this County's history and their names are listed on the following pages.

A word of caution; approximately two-thirds of the following names were obtained from hand-written State Commission Dockets spanning a period of nearly 150 years. Because of the wide range of handwriting styles, which I had to interpret, there may be some misspelled names. Also, it is apparent from reviewing JP Dockets locally and in conversation with a past JP, that there are omissions in the State Commission records in Indianapolis. Also, there were no state records available for the period 1863 through 1872.
